## DRESSAGE RULES AND GENERAL INFORMATION

1. **Entries:** All entries must be postmarked no later than 7 days prior to the show. Correct fees must accompany each entry form. Entries will be accepted on a first-come, first-serve basis. No number will be issued without completed entry, waiver, signature(s), and full payment. Parents or guardians must sign for minors. We cannot guarantee that all entries will be granted ride times even if postmarked by the closing date. For the safety of horses and riders, show dates are subject to postponement due to weather at the discretion of show management. ONLY EMAILED OR USPS MAILED ENTRIES ACCEPTED. Check or credit card only.
2. **Scratches:** Scratches made by Thursday prior to the show date will be refunded. It is the exhibitors' responsibility to inform [OnTheBitSYV@gmail.com](mailto:OnTheBitSYV@gmail.com) of their intention to scratch. No exceptions.
3. **Post Entries:** Post entries will only be accepted as space allows and/or to fill scratches if the schedule permits. A horse already entered in the show will receive priority. All applicable fees must be paid before or at check-in the day of the show.
4. **Late Fees:** Each entry postmarked after the closing date will be assessed a \$10.00 late fee. Jump 4 Fun NO LATE FEES
5. **Mandatory Fees:** All judged entries are subject to CA drug fee and facility fee.
6. **SYVEA Fees:** Non-member fee of \$25. Please see SYVEA membership form to join.
7. **Ride Times:** A complete schedule will be sent to competitors via email prior to the show date. Please include your email address on your entry form. Please notify us of any errors immediately.
8. **Minor Exhibitors:** Parents or guardians of minor exhibitors shall hold Santa Ynez Equestrian Association, Santa Ynez Valley Pony Club, and those associated harmless for injury to said minor(s). No minor's entry will be accepted without the signature of a parent or guardian. The signatures of instructors, agents, or other unrelated persons are not acceptable.
9. **Conditions of Entry:** Show management will, in no case, be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the horse show, Santa Ynez Valley Equestrian Center, Santa Ynez Valley Pony Club, On the Bit Schooling Show Committee and it's affiliates harmless for any loss or accident to his/her horse, horses or equipment which may occur from accident, sickness, fire, or otherwise. Show management reserves the right to postpone, cancel, combine, or divide classes, or to change officials as it deems necessary. The decision of show management is final.
10. **RIGHT OF REFUSAL:** On the Bit Schooling Shows reserves the right to refuse any entries.
11. **Protective Headgear:** Dressage classes will follow USEF Dressage rules. Western Dressage classes will follow WDAA rules.
12. **Arenas:** All tests will be ridden in a 20x60 meter sand arena. Only those horses entered in the show are permitted to use the show facilities, warm-up arena, round pen, and show arena. No one on foot is allowed in the dressage warm-up arena. Horses must wear competition numbers while on the grounds.
13. **EMT, Farrier, Vet:** Will not be available on the grounds.
14. **Tests:** Current USDF, USEF, FEI, and WDAA tests will be ridden. Callers are allowed.
15. **Ribbons and Awards:** Ribbons will be awarded to third place for Amateur and Open riders and to sixth place for Junior riders. 1st place prizes to classes with 3 or more entries. Daily High Point awards for the following divisions with 3 or more entries: Open, Adult Amateur, Junior and Western Dressage. High Point Pony Club Rider will receive a medal.
16. **Year End High Point:** Will be offered to the horse and rider combination who show in at least 3 shows in 2025, and awarded to the pair with the highest cumulative score at the end of the year. Highest cumulative score will consist of the horse/rider's highest daily score from each show. Separate awards for Open, Adult Amateur, Junior and Western Divisions.
17. **Lead Line:** No cross entry of rider in another class. Rider may be accompanied by 1, 2 or 3 responsible parties (a leader and 1 or 2 sidewalkers). Each participant will receive an award. No entry fee and no grounds fee.
18. **LUNGING:** Allowed in the lunge ring only. Minors must wear appropriate safety headgear.
19. For the safety and comfort of horses and exhibitors, no dogs and no alcohol are allowed on premises.
20. Please dispose of horse manure and trash in provided bins.

## JUMP 4 FUN RULES AND GENERAL INFORMATION

1. Rides will begin at 9:00 AM and the fences will be raised approximately every 30-45 minutes, depending on participants.
2. The jumps will start with ground poles and gradually increase in height.
3. Jumps may include verticals, fillers, and oxers.
4. There will be a 2 minute 30 second time limit per round. You will hear an audible sound when the time starts, at 30 seconds remaining, and when the time is up.
5. Jump course will be posted, but rider can choose their own course, repeat fences or skip fences as desired.
6. Trainers will be allowed in the jump arena to help student have a successful round. This is an opportunity to gain experience for yourself and horse away from home without the pressures of being judged.
7. You may do multiple rides at the same height if stated on the entry.
8. Additional rounds may be added, depending on time restraints.
9. **USEF rules apply. There will be no abuse towards any animals allowed. If a rider or horse is being asked to jump beyond their ability, they will be directed to leave the arena.**
10. **Boots, head gear and protective vests:** All entrants must wear properly fitting boots or half chaps with paddock boots and protective headgear passing or surpassing current applicable ASTM/SEI standards with harness secured while riding anywhere on the grounds. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place. It is the responsibility of the rider, or the parent or guardian or trainer of the junior exhibitor, to see to it that the headgear complies with appropriate safety standards and is properly fitted and in good condition. Santa Ynez Valley Equestrian Center, Santa Ynez Valley Pony Club, On the Bit Schooling Shows Committee and it's affiliates **are not** responsible for checking headgear worn for such compliance. Protective vests are allowed.
11. Management reserves the right to refuse, accept conditionally, and to cancel entries without claims or damage.
12. Stallions may be shown only by adults (18 years and older).
13. All children must be under adult supervision at all times.

RELEASE, WAIVER AND HOLD HARMLESS AGREEMENT**

I am aware and fully understand that horses can be dangerous and unpredictable animals. I realize that participants and even spectators attending equestrian activities and events place themselves in a potentially hazardous environment that poses a substantial risk of injury to persons and property, and that occasionally serious injury or even death to riders, horse-handlers, spectators and horses occurs. Nevertheless, by signing this agreement, I hereby, knowingly and voluntarily, with full appreciation for the danger, assume all risks of injury to my person, my children, my horse(s) and my property, no matter how catastrophic and no matter the cause, which may occur as a result of my use or my child's use of the Santa Ynez Valley Equestrian Association's ("Association") property, facilities and equipment, for any purpose, and/or my participation or attendance at, or my child's participation in or attendance at, any Association activity or event.

In consideration for allowing me use the Association's property and facilities, and for allowing me to participate and/or be a spectator at Association activities and events, on behalf of myself, my legal representatives, heirs, assigns and estate, I hereby release and hold harmless (agree not to make a claim against or sue) the Association, its officers, directors, employees and agents (collectively referred to hereinafter as "Association"), the owner(s) of property at which Association activities or events are conducted, and/or the operators of Association activities or events, and their respective employees, agents and assigns, from any and all duty, liability and responsibility to me and my children, our legal representatives, heirs, assigns and estate, that may arise from any accident, damage, injury or illness to me, my children, my horse(s) or my property, as a result of my use or my child's use of the Association's property, facilities or equipment, and/or my participation in or attendance at, or my child's participation in or attendance at, equestrian activities or events, including, but not limited to, any and all damage, injury or illness to me, my children, my horse(s), or my property, that may arise from the negligent acts or omissions (whether active and/or passive) of the Association and the operators of its activities or events.

In accordance with *California Civil Code section 1668*, this release of liability does not exempt the Association from responsibility for any fraud, or willful injury to the person or property of another, or from any violation of law.

I further agree to defend, indemnify and hold harmless the Association, the property owners and operators of its events, their employees, agents and assigns, against all claims, demands and causes of action (which includes court costs and attorneys' fees), brought by or prosecuted for my benefit or that of my children (i.e., pay any loss or damage that they may incur, including attorney's fees and costs).

I agree that this release extends to all claims of every kind and nature whatsoever whether known or unknown, foreseen or unforeseen, and expressly waive any benefits of *California Civil Code section 1542*, which states:

**A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM MUST HAVE MATERIALLY AFFECTED HIS SETTLEMENT WITH THE DEBTOR.**

I understand and acknowledge that the significance and consequence of this waiver of *California Civil Code section 1542* is that even if me, my child, my horse or my property is injured, damaged or becomes ill, I, and my legal representatives, heirs, assigns and estate will not be able to make any claims for those damages.

By signing this release, I hereby grant the Association, the operators of its activities and events, their employees, agents and assigns my permission to initiate emergency first aid treatment for myself and/or my children in the event such treatment is reasonably required, which determination may be made at their sole discretion.

I further agree and understand that this Agreement is intended to be as broad and inclusive as permitted by the laws of the State of California, and that if any portion of this Agreement is held invalid, then it is agreed that the remainder of this Agreement shall continue in full force and effect.
